ICU Peace Bell Scholarship Application Guidelines AY2026

In April 2008, International Christian University established the Peace Bell Scholarship with funds donated by alums, faculty, staff, and members of the general public who supported the scholarship aim. Undergraduate students who will serve as role models for ICU students for four years are awarded as "ICU Peace Bell Scholars" based on their recommendation letter and results in the admissions route. The selected scholars are required to submit reports periodically and maintain good academic performance as "ICU Peace Bell Scholars." Scholarship applications must be submitted at the same time as the admissions application.

< What is ICU Peace Bell?>

On the 50th Anniversary of ICU's foundation, the peace bell was donated to the ICU Chapel in honor of Mr. Hisato Ichimada, former governor of the Bank of Japan, who had dedicated himself to establishing ICU. The bell is engraved with the phrases from the First Epistle of Peter: "Let Them Seek Peace and Pursue It." The bell chimes on time every day, bringing prayer for world peace to people's hearts.

1. Outline of the Scholarship

(1) Scholarship Amount

- Matriculation fee: 300,000 JPY
- Annual tuition and facilities fees for AY2026: 1,521,000 JPY
- On-campus dormitory entrance fee and annual on-campus dormitory fees for AY2026 (fees for staying dormitory during Summer (July and August) will be at your own expense)
- Annual tuition, facilities fees, and annual dormitory fees (fees for staying dormitory during Summer (July and August) will be at your own expense) for AY2027-AY2029 (As for the amount of Tuition and Facilities Fees for AY2027-AY2029, refer to the ICU website.)

(2) Scholarship Period

In principle, four years (within the minimum period of enrollment for the University)

- * The period of leave of absence is also counted as part of the minimum period of enrollment for the University.
- * To continue receiving this scholarship, the ICU Peace Bell Scholarship recipients (hereafter "Scholars") must submit a scholarship renewal application each academic year and meet the grade and income requirements. Furthermore, if a Scholar conducts themselves in an inappropriate manner a Scholar during their enrollment at ICU, their eligibility for this scholarship may be rescinded.

(3) How to Grant

The annual tuition, facilities fees and annual dormitory fees (excluding July and August) for every academic year will be exempted. (There will be no cash transfer.)

- * If a Scholar does not register for courses due to a leave of absence, or other reasons, Non-resident Fees (30,000JPY/term) are to be borne by themselves, and lose their eligibility to reside in ICU dormitories, and their exemption from dormitory fees will be terminated.
- * If a Scholar withdraws from the University, their eligibility will be rescinded.
- * In the terms in which Scholars receive this scholarship, they cannot combine to receive the loan programs of affiliated financial institutions that ICU offers.

2. Eligibility

Applicants to the undergraduate program as regular students who hold high aspirations to enroll in ICU, whose character, academic achievement, and results in the admissions route are all acknowledged as outstanding. Also, the total amount of the income of their parents (or their household income earners if parents are not applicable) must meet the following requirements of either A or B:

- (A) For households whose income source is employment income (salary/wages):
 - The combined annual gross income of parents is less than 10 million yen (incl. tax).
- (B) For households whose source of income is NOT employment income (self-employed, etc.):

The combined annual gross income of parents is less than 5.65 million yen.

3. Expected Number of Awardees

14 Scholars (from all types of admissions routes in AY2026)

4. Applicable Types of Admissions Routes

All types of admissions routes excluding the admissions for transfer students are eligible.

- * If students are applying to ICU through multiple admissions routes, they can apply for this scholarship each time. However, they must prepare scholarship applications for each type of admissions route. For more information, refer to "Section 11: Information for Those Applying in Combination with the ICU Torch Relay High Endeavor Scholarship and / or through Multiple ICU Admissions Routes"

Scholars are selected by making an overall evaluation of various factors such as the quality of their application materials, results of the admission selection, and the state of household income.
